Pro Bono

The Colorado Bar Association has recognized David for his pro bono work related to First Amendment on-line speech and the use of intellectual property to curtail free speech. In the case of *Righthaven LLC v. Hill*, Civil Action No. 1:11-cv-00211-JLK (D. Colo.), David achieved dismissal with prejudice for his client based on the strength of a motion to dismiss for failure to state a claim, lack of personal jurisdiction, improper venue, and lack of copyright ownership interest by the plaintiff. The New York Times and other national news outlets ran numerous stories about the case.
