Civil Litigation

Patrick represents businesses and individuals in state and federal courts and in arbitration forums. He litigates a broad range of civil, real estate, and commercial disputes, including cases concerning adverse possession, bankruptcy creditors' rights, breach of contract, business formation, business torts, commercial landlord/tenant disputes, fiduciary duty, fraud, defamation, commercial leases, misappropriation, non-compete, prescriptive easements, property boundary disputes, and trade secrets. Patrick provides his clients with detailed investigation, diligent legal analysis, focused trial advocacy, and plain language communication.

Water & Environmental Law

Patrick represents a variety of clients with water and environmental law needs. He represents large municipalities with valuable senior water rights in need of protection and smaller irrigation companies and irrigators to protect their water rights. He has successfully represented clients in hundreds of water application proceedings, teamed with the Colorado Attorney General and U.S. Department of Justice to win a liability judgment in the U.S. District Court for Colorado against a large front-range municipality for violations of the Clean Water Act, and negotiated consent decrees for clients with air emission permit issues. He also negotiates and drafts agreements and transactional documents for water clients.

Patrick served six years in the U.S. Marine Corps, where he was decorated for his service in the first Persian Gulf War. After college, he spent ten years as an environmental scientist, working on Colorado's Rocky Flats Superfund Project, among other projects. After law school, Patrick served as a Deputy District Attorney for the 20th Judicial District (Boulder) and clerked for former 20th Judicial District Chief Judge Maria Berkenkotter (now a Colorado Supreme Court Justice).
